In consideration of being granted membership in the Sin City Victory Riders LLC, Victory Motorcycle Club Local Chapter #17, and in consideration of being permitted to participate in any and all Local Chapter #17 sponsored functions and activities (collectively, the "Events"), I have been advised of, understand, and agree to the following:

1. Club Dues. All applicants for membership shall pay membership dues according to the following fee schedule:

Note 1: Upon payment of initial dues, applicants for membership will receive one SCVR embroidered back patch and one SCVR logo'd T-shirt.

Note 2: The Fee/Dues for renewal of initial membership is \$60.00 per year payable no later than December 31st of the previous year.

2. Definitions:

a. *Adopted Meeting Location* - That place in which regularly scheduled club meetings take place or other location specifically designated and publicized for an intended purpose, e.g., ride meeting point.

b. *Calendar year* – Time measured from January 1st and ending December 31st without interruption.

c. *Club By-Laws* – Sin City Victory Riders, LLC Chapter By-Laws as amended and/or restated from time to time according to Article 6: By-Laws Amendment.

d. *Event* - A social gathering or activity organized by a Member or Club committee for the benefit or enjoyment of the entire club membership, and having been approved by a Club vote according to the By-Laws.

e. *Exempt Member* - A member whose place of residence is beyond a travel distance of 40 miles, one-way, as measured from that residence to the adopted meeting location.

f. *Meetings* - Regularly scheduled monthly club meetings for the purpose of conducting club business.

g. *Member* – Any person demonstrating consistency with the provisions of the Club By-Laws, the provisions herein, and having paid membership dues/fees according to the schedule herein.

h. *Non-Exempt Member* – Shall be any member not qualifying as an “*Exempt Member*”.

i. *Residence* – That place at which a member resides for not less than 3 consecutive months during the calendar year.

j. *Travel Distance* – Length of travel one way, measured in miles along the shortest route on paved public roads or highways.

3. Minimum Participation Requirements:

a. All *non-exempt* members shall attend not less than (3) three club meetings in each calendar year.

b. All *non-exempt* members shall attend not less than (1) planned and publicized club event in each calendar year.

c. Club members with regularly scheduled employment hours that conflict with regularly scheduled club meetings and/or club events for a period exceeding 6 months in any one calendar year, shall not be required to fulfill the requirements of subparagraph 3.a. and 3.b. above.

d. *Exempt Members* shall not be required to fulfill the requirements of subparagraphs 3.a. and 3.b. above.

e. All members shall remain in good standing according to the Club By-Laws. Loss of membership (*exempt*, or *non-exempt*) may be reinstated after a probationary period of 6 months in which the prospective member shall:

- (1) Attend not less than (3) club meetings,
- (2) Participate in not less than (1) planned and publicized club event, and
- (3) Continue uninterrupted payment of membership dues.

4. Liability Release and Assumption of Risk.

I understand that my participation in an Event can expose me to dangers both from known and unanticipated risk, including, but not limited to, risk associated with riding my motorcycle to, from or during an Event or interaction with persons, including other Local Chapter #17 members or others, at an Event. I willingly and voluntarily assume all such risks, including those of loss, damage or injury, including death, to myself and/or my property from any cause whatsoever. Moreover, acknowledging that such risk exists, I, for myself, my heirs, personal representatives and assigns, hereby release, discharge and hold harmless the Sin City Victory Riders LLC, the Victory Motorcycle Club, and any of its affiliates; the clubs, Chapters, the promoters, the landowners, and the sponsors, if any, co-hosting an Event; the owners and representatives, agents, members, successors, assigns, affiliates, and employees of all of them (collectively "Released Parties") from any and all claims or liability for personal injury, including death, or property damage I may suffer resulting from, arising in connection with, or related to the Event, including, but not limited to, any claims arising out of the conduct of any Event or Event-related activity. I specifically release the Released Parties and each of them for the negligence, in any form of any or all of the Released Parties. In signing this release, **I FULLY RECOGNIZE THAT IF I AM HURT AND/OR MY PROPERTY IS DAMAGED IN CONNECTION WITH THE EVENT, I WILL HAVE NO RIGHT TO MAKE A CLAIM OR FILE A LAWSUIT AGAINST THE RELEASED PARTIES, EVEN IF THEY OR ANY OF THEM CAUSED MY DEATH, INJURY OR DAMAGE.**

5. Indemnification.

I agree to indemnify and hold harmless the Released Parties, individually and/or collectively, from all lawsuits, claims, damages, costs, and attorneys' fees that arise out of my presence or conduct at an Event and/or my violation or my representative's violations of any provision of the Application. This provision will apply regardless of whether or not the lawsuit, claim, damages, costs and/or attorneys' fees arise out of the negligence, in any form, of any of the Released Parties. As I am releasing any claim my family, guardian, representative and/or estate might wish to make by reason of my injury or death, this indemnity provision shall specifically apply to such actions on my behalf and/or any such actions resulting from my injury or death.

6. Insurance Responsibility.

I understand that neither Sin City Victory Riders LLC nor the Victory Motorcycle Club provide health and/or life insurance. If I do not have insurance I deem appropriate, I agree that I should not

participate in an Event. I assume all responsibility for my doctor and/or hospital expenses and any loss or injury to personal property or myself in which I may become involved in by reason of participating in an Event.

As rider or authorized guardian of a rider, I certify that I have completely read this Application and by signing below, accept the foregoing terms as condition of my Membership.
